## Privacy Policy

The Braughing and District Pickleball Club (BaD) is committed to protecting and respecting your privacy. By completing a membership form, you have given consent for the club to hold the personal data you have provided. The Committee of the club is the Data Controller and is responsible for storing and otherwise processing the data in a fair, lawful, secure and transparent way.

BaD needs to hold your personal data to provide you with on-going organisational updates. BaD will not collect any personal data from you that is not necessary for the running of the club.

To protect your personal information, BaD will take reasonable precautions to ensure it is not inappropriately used, accessed, disclosed or altered. Personal data collected by the club will be stored on private computers and devices and will be password protected. Files will be backed up securely e.g. to a memory device or to the cloud. Any memory devices or paperbased records containing personal data will be kept safely.

BaD will hold your personal data on file for as long as you remain a member of the club.

As a data subject you have the right at any time to request access to, correction or erasure of your personal data. This can be done by notifying the club secretary in writing.
